ANNOUNCEMENT

The EU EYE has been officially accepted in the European Innovation Partnership on Active and Healthy Ageing (EIP-AHA) of the European Commission. This is a recognition of the efforts and the added value that the EU EYE brings to this collaborative network in creating a forum for integration of research priorities, policies and strategies in eye health. The EU EYE will explore potential synergy actions with members of EIP AHA who have similar interests and activities.

The commitment of the EU EYE was submitted to the B3 Action Group on Integrated Care of the EIP AHA in December 2017 and it has been now validated and publicly accessible at:

The <u>EIP-AHA</u> brings together key stakeholders in public health from universities, research groups, public authorities, health care providers, industry and non-governmental organizations representing citizens and patients. The following Directorate Generals are currently interested in the work of the EIP-AHA:

DG Connect (digital development of EU); DG SANCO (the public health unit); DG Research & Innovation; DG REGIO (managing the structural funds); and DG EMPL (DG Employment Social Affairs & Inclusion). The EIP-AHA has six thematic Action Groups:

- Action Group A1: Adherence to treatment
- Action Group A2: Falls prevention
- Action Group A3: Functional decline and frailty
- Action Group B3: Integrated care
- Action Group C2: Independent living solutions
- Action Group D4: Age friendly environments

European Council

Priorities on education and training

The European Council has called Member States, the Council and the European Commission to work on the following priorities:

- step up mobility and exchanges through a reinforced and extended Erasmus+ programme;
- strengthen partnerships between higher education institutions and encourage the emergence of twenty 'European Universities' by 2024, that enable students to combine studies in several EU countries and contribute to the competitiveness of European universities;
- encourage the learning of at least two European languages in addition to the mother tongue;
- promote student mobility and participation in activities through a 'European Student Card';
- promote cooperation on mutual recognition of higher and secondary education diplomas.

ERN-EYE

A European Reference Network dedicated to Rare Eye Diseases (ERN-EYE) has been launched with 29 members in 13 countries of the EU and covering more than 900 rare eye diseases.

The ERN scheme is a joint initiative of the European Commission and Member States with support from the European Parliament. The ERNs are networks for clinicians and researchers to share expertise, knowledge and resources across the EU. Their aim is to address common challenges in diagnosis and highly specialised care provision in complex, rare or low prevalence diseases. The ERNs are organised in disease groupings and are part of the legal framework of the EU Directive on Patients' Rights in Cross-Border Healthcare Directive adopted in 2011.

Health Work Programme for 2018

The Commission has adopted the Health Programme's Work Programme for 2018 (WP 2018) setting out the priorities and actions to be undertaken in 2018. The overall budget for 2018 is just over $\in 62$ million, with 64% being allocated to grants, 24% to procurement and 12% to other actions including prizes. The Work Programme 2018 will focus on the following areas:

- European Reference Networks for rare and complex diseases (29% of the budget);
- Health promotion and prevention of chronic and major diseases (15%);
- Mitigating cross-border health threats (15%);
- Implementation of medical devices legislation (7%)

CPMS bringing specialised care to patients in Europe

Clinical Patient Management System (CPMS) is a secure webbased platform enabling the ERNs' healthcare professionals to discuss diagnosis and treatment of patients with rare or low prevalence complex diseases or conditions across national borders. Such cross-border virtual consultations will reduce patient travelling to highly specialised healthcare providers. All ERNs will focus on: enrolling the first patients into the CPMS; launching the first virtual panels; and familiarising themselves with the platform's functionalities. The CPMS will eventually allow for doctors outside of the ERNs to enroll their patients for diagnosis, care and treatment advice from each ERN.

Standards for Rare Disease Registries

Registries across Europe are recommended to use, as the basis for their data collection activities, the uniform standard released by the European Platform on Rare Diseases Registration (EU RD Platform) to ensure comparability and interoperability for rare disease databases. The "*Set of Common Data Elements for Rare Diseases Registration*" describes sixteen essential data elements to be provided for research purposes together with instructions on how and in which format each data element should be registered. Such information is in addition to patients' personal data, diagnosis, disease history and care pathway.

The EU RD Platform has been developed by the Joint Research Centre and the Directorate-General for Health and Food Safety to tackle the issue of fragmentation of data regarding rare disease patients.

Cross-border digital prescription and patient data

In 2018, twelve EU Member States will start exchanging patient data on a regular basis. Sweden, Finland, Portugal, Croatia, and Estonia will share electronic prescriptions. Five more countries are scheduled to join the network in 2019, and another wave is expected for 2020.

Borderline medical devices

The European Commission has released an update to its manual on classifying "borderline" medical devices, which is a complement to *MEDDEV 2.1/3 Rev. 3*, the guidance document on products incorporating pharmacological or biological substances. The EU's new *Medical Devices Regulation* (MDR) and *In Vitro Diagnostic Regulation* (IVDR) will come into effect in 2020 and 2022, respectively. Borderline device decisions remain with each member state. The European Commission may make decisions on specific borderline products in consultation with the Medical Device Coordination Group (MDCG) and other relevant EU regulatory authority e.g. European Medicines Agency, European Chemicals Agency or the European Food Safety Authority.

Assessing educators' digital skills

The Digital Competence Framework for Educators (DigCompEdu) has been published by the European Commission to help





educators at all levels to self-evaluate their competence in relevant digital skills. DigCompEdu proposes twenty two elementary competences organised in six areas: professional engagement; digital resources; teaching and learning; assessment; empowering learners; and facilitating learners' digital competences. The framework further proposes proficiency levels from A1 (Newcomers) to C2 (Pioneer), in reference to the widely used language proficiency levels. The framework is part of a competence framework family that includes the Digital Competence Framework for individual citizens, the European Framework for Digitally Competent Educational Organisations, the Digital Competence Framework for Consumers and the Entrepreneurship Competence framework.
